DEVGAD

Devgad is primarily known for the temple of Dattatraya and for the temple of Kisangiri Maharaj, a saint and a messenger of Lord Datta. Near the temple of Lord Datta are the temples of Panchmukhi Siddheshwar, Shri Kartik Swami and of Goddess Parvati. Located along the banks of River Pravara and at 70 km from Ahmednagar, the temple of Devgad is a place so divine that it soothes your soul and spirit the very moment you walk in. The pristine premises are kept so well by the means of frequent cleaning and also because of the love for discipline shared by the devotees who visit this place. Currently this premises are managed under the guidance of Hari Bhakt Parayan Shri Bhaskargiri Maharaj. The entire temple is built using polished marble stones from Rajasthan. The temple has four feet high magnificent golden peak that inspires splendour for anyone who comes in the temple's vicinity. As you move towards the heart of the temple premises, you will experience a magical aura take over you, as you surrender to the divinity of Lord Datta!
