# **QUIZ and ELOCUTION CONTEST**

## **For CA Students**

### **TERMS AND CONDITIONS**

**ELIGIBILITY**– Students registered with the Institute for Final Course, Professional Competence Course and Integrated Professional Competence Course are eligible to participate in the contest. However, a person who has qualified in the final examination and completed articles / audit training is not eligible to participate.

### **Guidelines For Quiz Contest**

1. A team will consist of **two (2)** students.
2. Preliminary rounds will be held among all registered teams. **Five teams** will qualify for Final round.
3. The decision of Quiz master in all respects will be final and binding on all. No question can be raised in respect to correctness or mistake in either question or answer. The answer as decided by the Quizmaster for any question will be final.
4. There will be **eight rounds** of quiz contest covering **Accounts, Auditing, Corporate Laws, Taxation, Costing/Management Accounting/Financial Accounting, Information technology, Economics and General Awareness**. There can be other rounds at the discretion of the Quizmaster.
5. The winner team of quiz will be eligible for participation in Regional Level contest to be held at Kolkata. Expenses will be reimbursed by ICAI as per guidelines.
6. The medium of competition will be English but answering in Hindi will be allowed.

### **Guidelines For Elocution Contest**

1. A contestant may speak on **any one** of the subjects listed below:
  - i. Revised Schedule VI – A Step Towards IFRS.
  - ii. Responsibilities of the Independent Director : Are We Going Too Far?.
  - iii. Raising Money: Equity Market Vs. Debt Market
  - iv. Rationale of Taxation Initiatives in Curbing Black Money.
  - v. Inflation – A Curse for Indian Economy?
2. The Contestant will be allowed 10 minutes to express his/her views. The medium of competition will be either English or Hindi.
3. The contestants will be judged by a panel of judges and their decision will be Final and acceptable to all contestants. Decision of the organizers will be final in all other matters;
4. Four winners will be selected and they will be eligible for participation in Regional Level contest to be held at **Kolkata**. Expenses will be reimbursed by ICAI as per guidelines.

**APPEAL:** Students are requested to participate in both the Contests.
