
- 1. Assumptions build-up (Project Start Date, Gestation Period, Project Commissioning Date etc.)
  - Accommodating project delays
  - Upfront capex in a phased manner
- 2. Building automated timeline (FY)
- 3. Timing and Event activation Flags (True/False)
  - Operation Start Flag
    - Operation Continued Flag
    - Operational Year sequence counter
  - Loan Repayment Flag
- 4. Revenue Buildup (PPA / Merchant Sale) with YoY escalation in prices Assumption Sheet
- 5. Capex Schedule (The journey from Capex > CWIP > PPE or Gross Fixed Assets)
- 6. Use of BASE Analysis (Beginning, Addition, Subtraction, Ending)
- 7. Amortization/Depreciation schedule
- Building depreciation calculations that stops after the book balance is fully depreciated
- 8. Interest during Construction (IDC) to be capitalized
  - Hard Capex vs. Soft Capex (IDC)
  - Dividing Interest accrued between IDC and P/L in the year of start of operation
- 9. Waterfall Structure of funding
  - Equity drawdown, followed by Debt and Grants
- 10. Incorporating Revolver Balance & Minimum Cash Balances
- 11. Debt schedules & repayment
- 12. Working Capital schedule & Linkages
- 13. Building iterative calculation for Interest
  - Incorporating circularity switch to build a failsafe mechanism in case iteration leads to irreversible errors
- 14. Others: IRR, NPV, Ratios, What If Analysis, Relevant Shortcuts
