Notes:

1. Chartered Accountants with a minimum of four years standing in practice or in service are eligible to apply.
2. University Lecturers/Professors with a minimum of five years teaching experience are eligible to apply.
3. Persons above 60 years of age are not eligible for empanelment as examiner.
4. Brief description of nature of work (Professional or Teaching) handled and handling be attached.
5. Copies of Mark sheets/Degree/Passing certificate/COP/ other relevant testimonials must be attached.
6. Persons who are undergoing any course of the Institute cannot seek empanelment.
7. All columns must be filled in or struck off if not applicable; else such incomplete application will be rejected.
8. Those who are not empanelled earlier or rested/removed from the panel are not eligible to apply again.
9. The empanelment process would take considerable long time, say 4-6 months and no interim correspondence, in meantime, will be entertained.

***Definition of Relative**
