Sub: Fixation of Fee for Foreign students registered for pursuing ICWAI courses

The Council of ICWAI in its 266th Meeting held on 30th December, 2010, has approved the followings:

Fixation of Fee for Foreign Students registered for pursuing ICWAI Courses; The details are as follows:

Fixation of Fee for Foreign Students registered for pursuing ICWAI Courses;

Students intending to pursue ICWAI Courses, having their domicile outside India, for the purpose of employment or otherwise, shall be charged fees as per **Annexure I**. Henceforth, fees received from Foreign students, in INR (Indian Rupees), shall not be considered valid. This shall be made effective from the date of issuance of this circular.

Explanation:

Students registered with any Regional Council/Chapter/ Recognized Oral Coaching Centres, but is now residing outside India for the purpose of employment or otherwise, shall also be eligible to claim exemption from GD/BC and /or Computer Training (for Intermediate, Modular Training (for Final), provided they have made an application to the Director of Studies, alongwith the prescribed fees, as applicable to a Foreign Student, within the prescribed time limit.
