Payment of fees for the Assessment Test should be made only by Demand Draft. The Demand Draft may be of any Scheduled Bank and should be drawn in favou r of "The Secretary, The Institute of Chartered Accountants of India, payable at New Delhi" only. Application together with the prescribed fee be sent so as to reach the Additional Secretary (Exams) at New Delhi on or before **3rd June - 2011.**

Applications for admission to the Assessment Test is required to be made in the prescribed form which may be obtained from the Additional Secretary (Exams), The Institute of Chartered Accountants of India, ICAI Bhawan, Indraprastha Marg, New Del hi – 110 002 on payment of Rs.100/- per application form. The forms are also available in the Regional and Branch Offices of the Institute and can be obtained upon cash payment on or from 15th May, 2011. Alternatively, the format of application form can be downloaded from the website of the Institute viz. <u>www.icai.org</u> and the cost of the application form of Rs. 100/- can be added to the Assessment Test fee of Rs. 1000/- and the Demand Draft for Rs. 1100/- has to be sent. The last date for receipt of duly filled in application forms is 3rd June - 2011. The application together with the prescribed fee should be sent by Speed Post/Registered Post to the Additional Secretary (Exams.), New Delhi. The applications receive d after 3rd June - 2011 will not be entertained under any circumstances.
