In 2008, the Institute of Chartered Accountants of India (ICAI) signed an historic Memorandum of Understanding with the Institute of Chartered Accountants England and Wales (ICAEW) for the benefit of its members. The arrangement allows ICAI members with two years of post-qualification experience to obtain ICAEW membership on passing the ICAEW's final advanced level paper called the 'Advanced Case Study'.

ICAI is now offering training for the Advanced Case Study in India exclusively through accredited training providers and publishers, Get Through Guides (GTG). GTG and ICAI have jointly designed a 10-day training programme for ICAI members that will give them the best chance to obtain ICAEW membership.

THE CASE STUDY EXAMINATION

The Case Study is the 4 hour final paper for all ICAEW member candidates and aims to test candidates' professional skills in the context of business issues, building on the technical skills and learning outcomes acquired studying for previous examinations.

Candidates are given Advanced Information 4 weeks before the examination to 'set the scene' (who they are and the area they are working in – approximately 50 – 60 pages) and during the exam must undertake work required in the paper, taking into account approximately 10 pages of new information provided.

BENEFITS OF TAKING THE CASE STUDY


The Case Study is different from most other examinations. The methodology behind the Case Study will facilitate developing capabilities to understand complex case scenarios, based on real-life business situations. Candidates will be required to work logically through the data available to put that case (client) information into a broader context. This will be invaluable when working in practice, for an MNC or running a business.

The case study will teach you to

- adopt a multi-disciplinary approach and demonstrate your ability to use judgement as well as highlight your technical skills
- apply classroom learning to the practical issues facing you
- consider genuine problems and come up with real-life solutions that manage both finance and risk
- develop good communication skills, business awareness, professional judgement and the application of technical accounting knowledge
- use knowledge from different areas in the same situation and confidently advise on what could take the business forward

THE 10 DAY STUDY PROGRAMME

A rigorous study programme has been specifically designed to take into account the knowledge of ICAI members. It is a combination of face to face tuition and members studying at home.
