- (a) The Income Tax Department maintains year-wise data of Income Tax Disputes at various appellate stages which is provided in *Annexure-A*.
- (b) The details of the number of pending appeals/cases and the amount involved therein (in lakh rupees) at various appellate level is provided in *Annexure-A*.
- (c) The data of number of pending appeals in Income Tax matters and the corresponding amount locked up is maintained separately for each appellate level (as provided in Annexure-A) i.e.
 - (i) First appellate authority [CIT (A)/JCIT (A)]
 - (ii) Income Tax Appellate Tribunal (ITAT)
 - (iii) Hon'ble High Courts, and
 - (iv) Hon'ble Supreme Court of India
