(11)	Requirement for passing Special Examination for Members of Foreign Accounting Bodies with whom the ICAI had entered into Mutual Recognition Agreement (MRA) / Memorandum of Understanding (MoU)	<ul style="list-style-type: none"> A candidate for the Special Examination for Members of Foreign Accounting Bodies with whom the ICAI had entered into Mutual Recognition Agreement (MRA) / Memorandum of Understanding (MoU) shall be declared ordinarily to have passed the examination if he/she obtains at one sitting a minimum of 40% marks in individual papers and a minimum of 50% marks in aggregate of such papers.
(12)	Issue of Statement of Marks and Pass Certificate of Special Examination for Members of Foreign Accounting Bodies with whom the ICAI had entered into Mutual Recognition Agreement (MRA) / Memorandum of Understanding (MoU)	Statement of Marks will be issued to all the candidates in Special Examination for Members of Foreign Accounting Bodies with whom the ICAI had entered into Mutual Recognition Agreement (MRA) / Memorandum of Understanding (MoU) normally in two weeks from the date of declaration of result, while pass certificates to the candidates declared passed will be issued normally in three months from the date of declaration of result.
