DATE(s) AND TIMING OF POLLING AND ADDRESSES OF POLLING BOOTHS [as on 13th November, 2009]

Members are aware that the next elections to the Twenty-first Council and Twentieth Regional Councils of the Institute are scheduled to be held in December, 2009. While a separate communication is under issue to every member entitled to vote at a polling booth intimating the date(s) of polling, address of polling booth where he has to cast his vote and manner in which vote is to be cast, however, the following details pertaining to elections are published for general information of members at large. It is also clarified for information of members entitled to cast their vote by post, including members abroad that the ballot papers along with the bio-data of candidates are under issue to them by registered post/speed post, as the case may be, at their professional addresses as published in the List of Voters.
