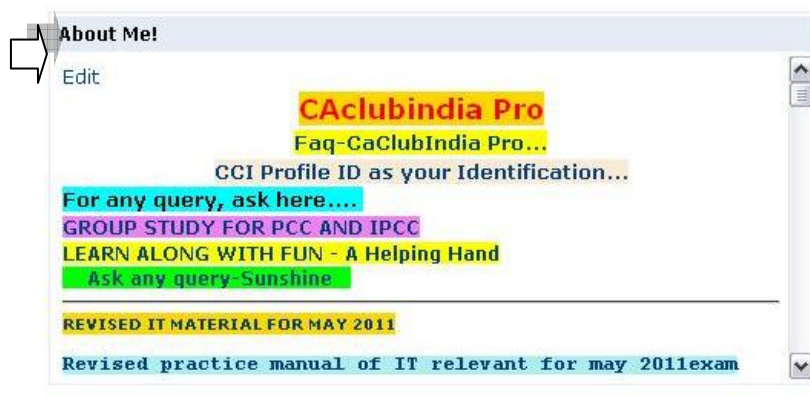
- After creating account you can login and use. ()

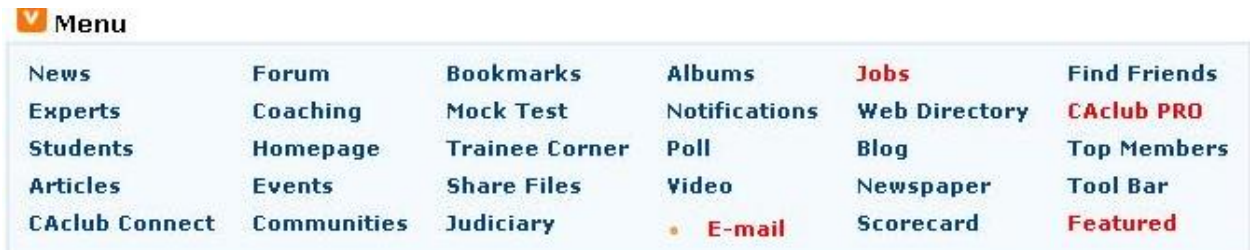

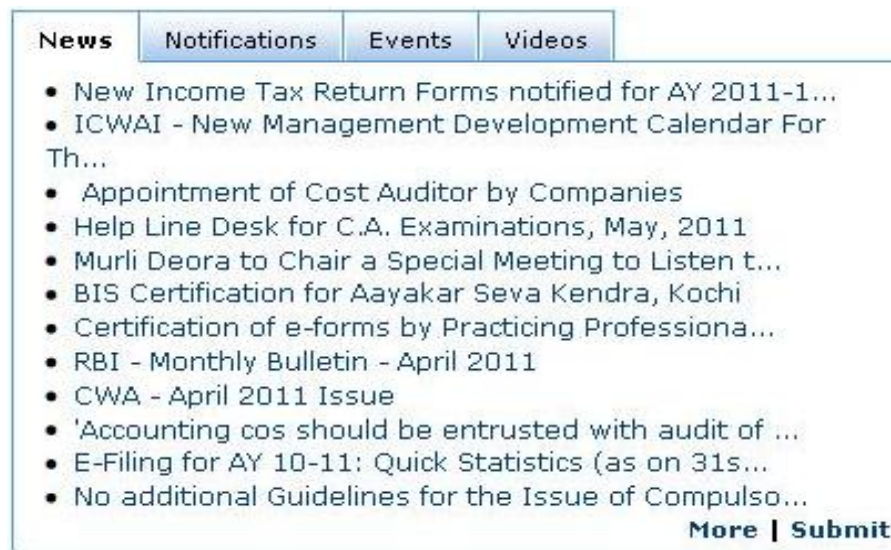
