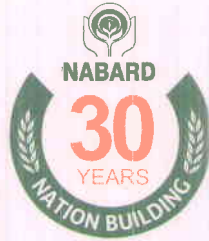

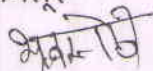

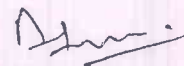

Sir,

I am directed to convey herewith Administrative Approval of GOI for continuation of Central Sector Scheme of Capital Investment Subsidy for construction /renovation /expansion of rural godowns with the budget of **Rs.350.00 crore** (Rupees Three hundred fifty crore only) to be implemented through NABARD, NCDC and NIAM during the financial year 2013-14. Various components of budget & patterns of assistance under the above scheme are as under:-

B) Important Components

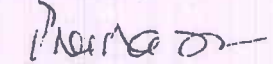
1. Projects for construction of rural godowns can be taken up by individuals, farmers, Group of farmers/growers, Partnership/ Proprietary firms, Non-Government Organizations (NGO's), Self Help Groups (SHGs), Companies, Corporations, Co-operatives, Federations, Agricultural Produce Marketing Committees, Marketing Boards and Agro Processing Corporations in entire country. Projects for renovation of rural godowns under above scheme can be taken by co-operatives only.

2. Under the scheme, entrepreneur will be free to construct godown at any place, as per his/her commercial judgment except for restriction that it would be outside limits of Municipal Corporation area and be of minimum capacity of 100 MT. Rural godowns of smaller size upto 50 tonnes capacity will also be eligible as a special case based on viability. In hilly areas rural godowns of smaller size upto 25 tonnes will also be eligible for subsidy.
3. Godowns built under scheme shall be structurally sound on account of engineering considerations and functionally suitable to store agricultural produce. To ensure scientific construction and operation of rural godowns, entrepreneurs will be required to obtain license from State Warehousing Corporations to operate such godowns under State Warehousing Act.
4. Subsidy under scheme is linked to institutional credit and will be available to only such projects as are financed by Commercial Banks, Cooperative Banks and Regional Rural Banks. Loan to entrepreneurs from banks for construction/renovation/expansion of godowns would carry an adequate long-term repayment period.
5. Assistance under scheme will be available on capital cost of construction of godown only including allied facilities like consumer coop., agri-clinics, weighing, grading, packaging, quality certification, warehousing etc. to meet various requirements of farmers.
6. Farmers keeping their produce in godowns will be eligible to avail pledge loan on hypothecation of their produce. Terms and conditions governing pledge loans viz. margin, rate of interest, period of pledge, amount etc. will be as per guidelines issued by RBI/NABARD and as per normal banking practices followed by financial institutions.
7. Rural godowns constructed in Food Parks promoted by Ministry of Food Processing Industries will also be eligible under scheme for assistance, provided the same is in rural area and satisfy other conditions of the scheme.
8. General awareness programme on scheme for farmers and a training programme for entrepreneurs for construction, maintenance and operation of rural godowns will be organized by Ch. Charan Singh National Institute for Agricultural Marketing, Jaipur (NIAM).
9. Scheme shall be implemented by Directorate of Marketing & Inspection, Faridabad (DMI) an attached office of Department of Agriculture & Cooperation.
10. This approval is subject to condition that no staff or post will be created and also no vehicle etc. is purchased under any component of the scheme sanctioned.
11. It is requested that consolidated proposals giving full details or funds required for implementation of scheme may please be furnished to this Department, on priority basis.
12. Details of amount allocated for various projects alongwith physical targets may be furnished by implementing agencies to DMI in form of a consolidated statement indicating location of projects sanctioned, approved outlays, subsidy component (separately for North-Eastern States, Hilly areas and SC/ST and capacity of godown).
13. Progress report indicating physical and financial achievements will be obtained by Directorate of Marketing and Inspection every month, from implementing agencies by 10th day of succeeding month.
