- a. *the holder of a CPA Australia-recognised degree and who has successfully completed:*
- (i) the CPA Program; and*
 - (ii) the Mentor Program;*

- b. *a Member of CPA Australia that does not fall under either paragraphs (i) or (ii) but who has at least fifteen (15) years' work experience, at least five (5) years of which has been at the senior level.*

Disqualification : ICAI is not obliged to admit as its member any member of CPA Australia who:

- (a) is a Member of CPA Australia by virtue of an MRA or any other mutual recognition arrangement with another professional body;*
- (b) is a subject of a current investigation into his or her professional conduct; or*
- (c) has been subject to any disciplinary sanctions within the five (5) years prior to his or her application for membership of ICAI.*
