Subject: Formation of Service Tax Mumbai-I and II Commissionerates -reg

The Trade Notice No.1/2004 - ST dated 22.09.2004 issued under F.No.II/3-14/CCO/MCX-I/2004 is amended as under.

In terms of Ministry of Finance Order No. 1/1/2010 - Service Tax dated 10.02.2010 the existing Service Tax, Mumbai Commissionerate will be bifurcated to form Service Tax-I and Service Tax-II Commissionerates. The two new Commissionerates shall start functioning from 1st March, 2010 at the following addresses till further orders.
