

## CARO 2015 – Clause wise Comparison with CARO 2003

After a long wait, MCA has notified the Companies (Auditor's Report) Order, 2015 (CARO) on 10<sup>th</sup> April, 2015. There was a lot of debate amongst professionals as to whether CARO will be **applicable for the audit of the financial year 2014- 15**. MCA has finally ended the debates by notifying CARO.

*For ease of understanding I have prepared **Clause wise Comparison of CARO 2015 vis-a-vis CARO 2003**.*
